The IRS

Contributions to The Rotary Foundation must be mailed prior to Dec. 31 so that donors receive letters of receipt for use as they prepare their income tax returns. Contributions are tax deductible, likely setting the stage for some return to you from the IRS.

Submit your contributions early; do not wait until year-end. The Rotary Foundation will invest the funds and expect to get a much higher earning return than if they remained in your club's bank account.

States. The ranking is based on

monetary contributions from private sources and reflects the increasing generosity of those who support Rotary's mission.


According to The Chronicle of Philanthropy, the Foundation received \$259,594,884 in 2014, an 8.3 percent increase from the previous year.

The Foundation recently received a 4-star rating from Charity Navigator, the largest and most prestigious independent evaluator of nonprofits in the U.S.
